ORDER:-

In exercise of the powers conferred by sub section (1) of section 23 of the RTE Act, NCTE, New Delhi had laid down minimum qualification for a person to be eligible for appointment as a Teacher in classes I to VIII in its Notification dated 23.08.2010, the Governor of A.P .hereby makes the following amendment to the APTET, Rules 2011 issued in G.O.Ms.No. 51, SE(Genl II) Dept., Dated: 16.04.2011 :-

**Amendment**

In the said rules.

In Annexure for (1) (a), the following shall be substituted :-

- a) The candidate at the time of applying for TET should be in possession of the minimum qualifications prescribed for a teacher of category of I to V Classes (Paper – I) and VI to VIII classes (Paper – II) separately in NCTE Notification, dated 23<sup>rd</sup> August 2010 and or the qualifications of Language Pandit Teachers.

(OR)

A person who is pursuing (Final Year) any of the Teacher Education Courses (Recognized by the NCTE or the RCI, as the case may be) specified in the NCTE Notification dated 23<sup>rd</sup> August, 2010 and or the Language Pandit Training Courses during the academic year.

2. The Commissioner & Director of School Education , A.P., Hyderabad., shall take necessary action accordingly.
